NOTIFICATION

This is for information of all concerned that fresh applications are sought from the Registered Research Scholars of Dibrugarh University for the Dibrugarh University Research Fellowship (DURF) Scheme for the year 2020-2021 with the following terms and conditions:

Terms and Condition:

1. One Dibrugarh University Research Fellowship (DURF) per Departmental Research Committee (DRC) per year has been instituted.
2. The registered research scholars of Dibrugarh University who are not availing/has not availed any other fellowship/scholarship are eligible to apply for the Dibrugarh University Research Fellowship.
3. The research scholars to be awarded the fellowship (s) shall be selected on 'Merit Basis' by the concerned Departmental Research Committee (DRC).
4. The research fellowship shall be awarded for a period of 1 (one) year which may be extended for another year subject to satisfactory progress report from the concerned DRC.
5. The Dibrugarh University Research Fellowship shall be awarded w. e. f. 1st August of each year.
6. During the tenure of the fellowship, if a research scholar receives/select for any other fellowship from other source, viz. UGC, DST, etc. he/she will have to resign from the DURF before joining the new fellowship awarded to him/her.
7. The amount of Dibrugarh University Research Fellowship shall be Rs. 5,000/- (Rupees five thousand) only per month.

The Chairpersons of the DRCs of Dibrugarh University are requested to send the recommendations of the DRC Concerned regarding nomination of the Research Scholar considered as eligible for the DURF for the session 2020-2021 latest by 10th August, 2020 to the office of the Joint Registrar (Academic), D U so that the fellowship may be awarded with effect from August, 2020.
