
NOTIFICATION

Under report to the Under Graduate Board, Post Graduate Board and Academic Council, Hon'ble Vice Chancellor, Dibrugarh University is pleased to approve creation of 4 (four) seats on supernumerary basis for the sons and daughters of Dibrugarh University employees in different Academic Programmes conducted by the Centres for Studies, Dibrugarh University as per the following details-

- (i) The 4 (four) seats in the various Under Graduate and Post Graduate Academic Programmes of Dibrugarh University are created on supernumerary basis for the sons and daughters of Dibrugarh University employees working in the regular posts. Among these 4 (four) seats, 2 (two) seats will be reserved for the eligible candidates of the Under Graduate Programmes and another 2 (two) seats for the eligible candidates of the Post Graduate Programmes offered by the Centres for Studies, Dibrugarh University.
- (ii) These 4 (four) seats created on supernumerary basis are non-transferable to other categories, but will be interchangeable between the Under Graduate and Post Graduate Programmes offered by the Centres for Studies, Dibrugarh University.
- (iii) Only 1 (one) seat in an Academic Programme will be created and allotted in a particular academic session.
- (iv) The intending candidates must fulfill the minimum eligibility criteria for admission to the academic programme concerned and must follow the prescribed application procedure.


The above shall come into effect from the 2020-2021 Academic Session.
