**NOTIFICATION**

In pursuance of the decision of the 120<sup>th</sup> Meeting (Special) of the Academic council, Dibrugarh University held on 12.08.2020, the University shall reserve 10% seats for the Economically Weaker Sections (EWs) in its various Academic Programmes w.e.f. 2020-2021 session. The eligibility norms for the EWs as per the Government of Assam Office Memorandum No. ABP.07/2019/3 dated 2<sup>nd</sup> February, 2019 are as below:

1. Persons *who are not covered under the existing sections of reservations for the Scheduled caste, the scheduled Tribes and OBC/MOBC and whose family has Gross Annual Income below Rs. 6.00 lakh* are to be identified as EWs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation his/ her parents and sibling below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources, i.e Salary, agriculture business, profession etc. and it will be income for the Financial Year prior to the year of application. *Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWs, irrespective of the family income.*
  - a. Agriculture Land more than 15 Bigha in rural area.
  - b. Residential land in rural area more than 1 Bigha.
  - c. Residential plot in notified Municipal corporation/Municipal Board/ town Committee Area more than 1.5 Katha.
  - d. Residential Built up area more than 1000 Sq. ft. in notified Municipal Corporation/ Municipal Board/ Town Committee.
2. The income and assets of the families as mentioned in Sl. No. 1 above will be required to be certified by an officer *not below the rank of Circle Officer*. The officer who issues the certificate would do the same after carefully verifying all relevant documents.

In view of the above, the intending eligible candidates who had already applied or intending to apply (*Only for M.B.A Programme*) for the following Academic Programmes are requested to submit the supporting documents along with the *downloaded Application Form which was submitted online* as attachments to the E-mail ID: [ews@dibru.ac.in](mailto:ews@dibru.ac.in) on or before **15.09.2020**. The candidates are requested to mention the *name of the Academic Programme in the 'Subject' of the E-mail*. Incomplete Application Form/E-mail without supporting documents shall be summarily rejected.


