Sub: Conduct of B.A./B.Sc. 2nd Semester (CBCS and Non CBCS) and 4th Semester (Non CBCS) Practical Examinations, 2020 -regarding.

This is for information of all concerned that the following procedure be adopted for the progression of students in B.A./B.Sc. 2nd Semester (CBCS and Non CBCS) and 4th Semester (Non CBCS) Examinations 2020 in Practical Courses.

- Backlog Examinations for Practical Courses of B.A./B.Sc. 2nd and 4th Semester (Non CBCS), 2020, if any, should be conducted by the concerned Colleges for 50% of the total marks.
- 2. Progression of regular candidates in Practical Courses of B.A./B.Sc. 2nd Semester (CBCS) and 4th Semester (Non CBCS), 2020 shall be done by Dibrugarh University as per the modalities followed for Theory Courses of the aforementioned Examinations. *However, I.A. Marks for the aforementioned examinations should be awarded by the concerned Colleges as per the relevant rule.*
- 3. In order to make up for the academic losses due to COVID-19 pandemic, the syllabus of Practical Courses of B.A./B.Sc. 2nd Semester (CBCS) and 4th Semester (Non CBCS), 2020 may be incorporated with the higher Semesters (3rd and 5th Semester Courses respectively for the session 2020-2021 only). However, there shall not be any credential for such extra portion of the syllabus in the respective examination.
