# ADMISSION NOTICE FOR Ph.D. AND M.PHIL PROGRAMMES SESSION 2020-2021

The *DURAT 2020* and/or UGC-NET (including JRF)/ UGC-CSIR NET (including JRF)/SLET/GATE/GPAT qualified candidates/ Teacher fellowship holders or have passed M.Phil programme (in regular mode and in the concerned subject), who are intending to take admission to the *Ph.D. and M.Phil Programmes* for the *2020-2021* session are hereby informed to apply for admission with the following documents to the Department/ Centre/ Institute concerned on or before *25.01.2021* in the prescribed format given as Annexure A:

- a) A print copy of the Application Form of the DURAT 2020 generated after submission.
- b) A copy of the DURAT 2020 Score Card downloaded from the University website.
- c) The copies of the Pass Certificates and Mark Sheets from HSLC to Masters Degree.
- d) Caste Certificate {in case, the Candidate belongs to SC/ST or OBC/MOBC, Differently Abled category.}
- e) No Objection Certificate (in case, the Candidate is employed).
- f) The UGC-NET (including JRF)/ UGC-CSIR NET (including JRF)/SLET/GATE/GPAT qualified candidates or the Teacher fellowship holder candidates shall have to submit a copy of the Award Letter in lieu of the DURAT documents.\*
- g) The M. Phil programme passed candidates (in regular mode and in the concerned subject) shall have to submit the M. Phil Degree Pass Certificates and Marksheets in lieu of the DURAT documents.\*
- h) All documents submitted by a candidate should be self-attested.
  - \* The candidates applying under (f) and (g) shall have to submit a Copy of the Receipt of Application Fee of Rs.500/- deposited at Punjab National Bank, Dibrugarh University.

#### **Admission Requirements:**

(i) A candidate seeking admission to the course for the degree of Doctor of Philosophy (Ph.D.) shall have to obtain at least 55% marks in Master's Degree OR equivalent Grade point.

Relaxation upto 5% marks may be availed by the candidates belonging to the reserved categories.

All applicants seeking admission to the Doctoral programme of the University [except foreign students applying for admission as provided for under clause 9] must clear the Dibrugarh University Research Admission Test (DURAT) (See Annexure I\*).

The DURAT is to be conducted annually by the University. The mode of the DURAT shall be decided by the Research Council time to time.

The candidates who have qualified the UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/ GPAT/ teacher fellowship holder or have passed M.Phil programme (in regular mode and in the concerned subject) are exempted from appearing the DURAT. However, these candidates have to apply for admission as per the University Notification. These candidates have to appear a viva-voce/ interview for getting selection for admission.

Not more than 50% of the seats in the subject concerned shall be filled up by the candidates, who are exempted from appearing the DURAT as per the provisions above.

- (ii) A candidate may also be enrolled if she/he has any other degree recognised as equivalent to the Master's Degree in the subject in which the candidate wishes to pursue a course of research, provided the candidate fulfills the conditions at (i) above.
- (iii) Under special circumstances, a candidate may be allowed by the Research Council to undertake research in a subject other than one in which she/he has obtained Master's Degree. Before permitting the candidate to do so, the Council shall satisfy itself that the branches are inter-related and/or the candidate is competent to undertake research in the particular subject as evidenced by published/practical works.
- (iv) A candidate with a B.E./B.Tech. Degree with a valid JRF-GATE score may also be considered for admission to the Ph.D. programme.

#### **Admission Procedure:**

- a) The Teaching Department/ Centre of Studies concerned shall receive the documents in the Prescribed Application Form (Annexure A) of the intending candidates till 4.30 P.M. of 25.01.2021.
- b) The list of the candidates invited for Viva-Voce shall be notified by the University concerned in the website: www.dibru.ac.in by 03.02.2021.
- c) There will be a Viva Voce Examination for all the candidates as below:
  - 1. For 30 % weightage for the candidates qualified the DURAT 2020
  - 2. For 100% weightage for the candidates who are exempted from appearing the DURAT 2020

- d) The admission to the Ph.D. and M.Phil Programmes shall be within 03<sup>rd</sup> to 9<sup>th</sup> February, 2021 at the teaching Department/ Centre of Studies concerned. The actual schedule of admission shall be notified along with the list of candidates selected for admission in the University website.
- e) The candidates selected for admission into the Ph.D. or M.Phil Programmes shall have to deposit their Admission and Course Fees of Rs. 6,000/- only through Online Payment mode by using their Debit Card/ Credit Card/ NET banking. The candidates are advised to send mail to techsupport@dibru.ac.in for any support regarding deposit of their fees. It may be noted that except Online Payment, no other mode of transaction is permissible.
