This is for information to all concerned that, the last date for submission of **filled-in Registration Forms** along with requisite fees (Rs. 350/- per non-domicile student from Assam for fresh registration and Rs. 600/- per non-domicile student from Assam for registration on migration) of the **B. Ed. 1<sup>st</sup> Semester Programme** under Dibrugarh University is **31<sup>st</sup> March, 2021**. Complying Office Memorandum No. AHE.639/2018/16 dated, Dispur the 10<sup>th</sup> June, 2020, the registration fee for the Academic session 2020-2021 of all students (domicile from Assam) studying at various Govt./Provincialized (under Directorate of Higher Education) colleges and Institutes under the territorial jurisdiction of Dibrugarh University are hereby waived off. However, the benefit of fee waiver will not include non govt./non Provincialized Colleges/Institutes and self-financing courses of the Colleges/ Institutes. The Head of the Department of Education, DU and all the Principals of affiliated B.Ed. colleges under Dibrugarh University are hereby requested to submit the registration as well as already D.U. registered student information data **through online mode (URL - <http://regn.epizy.com>) supported by two hard copies** on or before **31<sup>st</sup> March, 2021** at the office of the undersigned without fail. Already registered students of Dibrugarh University must not submit any fees, but their details needs to be entered in the web portal.

The user id and password for accessing the online registration software will be the same as sent earlier to all the concerned through mail.
