REVISED NOTIFICATION:: NINETEENTH CONVOCATION, 2021

It is hereby notified for information of all concerned that in view of the prevailing situation due to rise of COVID-19, the 19th Convocation of Dibrugarh University shall be held in virtual mode on 25th April 2021 as a precautionary measure to avoid transmission of the pandemic. On behalf of His Excellency the Governor of Assam as well as the Chancellor of Dibrugarh University, Professor Lilakanta Nath, Hon'ble Vice Chancellor (In Charge) shall confer the Degrees to the eligible candidates in a simple function to be held on the occasion in presence of the Deans of the University, which will be live streamed through the website-www.dibru.ac.in on 25.04.2021 from 11.30 a.m. onwards. The Director of Indian Institute of Information Technology (IITG), Guwahati Professor Gautam Barua shall deliver the Convocation address in virtual mode as the Chief Guest. Noted litterateur *Padmashree Yeshe Dorjee Thongchi* shall be conferred the Doctor of Literature (D.Litt.) Degree (Honorary) for his valuable contribution as a Litterateur, Critic, Academician and Social reformer.

This Convocation shall confer the Degrees on the eligible candidates, who qualified for their degrees of the University during the period from 01.11.2018 to 30.11.2019 (applied from 01.11.2018 to 10.01.2020 for Ph.D. Candidates only) in absentia.

Further, it is also informed to all concerned that due to the threat of COVID-19 pandemic, candidates of any degree could not be invited to receive their Degrees 'in person'. The eligible candidates shall be able to collect the Certificates w.e.f. 10th May 2021 from Dibrugarh University and from the respective Colleges. The University sincerely regrets the limitation compelled by the present situation and appeals cooperation from all concerned.
