Annexure- A

Modalities for conducting the B.Ed. 4th Semester (End Semester) Examination, 2021

A) B.Ed. 4th Semester (End Semester) Examination:

- 1. The End semester examination shall be conducted through **offline** mode.
- 2. The end-semester examination shall be carried out by a Board of external and internal examiners appointed by the University.
- 3. All the Covid19 protocols as prescribed by the Government shall have to be followed at the time of conducting offline examination.
- 4. This **Special provision** for conduct of the 4th semester B.Ed. examination is **exclusively for the current Academic session 2020-2021** in view of the present COVID 19 pandemic situation.
- 5. Each candidate shall have to prepare 2 (two) lesson plans (one in each subject chosen as Pedagogy content knowledge course) for final teaching practice. However, he/she will be required to appear in only one subject in the final teaching practice examination as decided by the external examiner. Final teaching practice examination will be held among the peer groups consisting of 8 to 10 peers. The duration of the lessons for final practice teaching shall be of 20-25 minutes.
- 6. The teaching practice shall be followed by a *viva-voce* to be conducted by the same Board of Examiners. The candidates shall have to submit the following documents at the time of *viva-voce*:
 - i) A report on Understanding Self comprising of at least three activities
 - ii) A report on Action Research or a proposal of Action Research or Case Study Report as per Annexure-B
 - iii) A report on Community Work as per Annexure-C
 - iv) A master time table for a Secondary school
 - v) At least **3 (three)** notices for Secondary school students/teachers
 - vi) At least **10 (ten)** Teaching Learning Materials (**5 each** for two subjects chosen as Pedagogical Content Knowledge Courses)
 - vii) **Thirty (30)** Lesson Plans (**15 in each subject** chosen as Pedagogical Content Knowledge Courses)
 - viii) **Two (2)** Digital Lessons (**one each** for two subjects chosen as Pedagogical Content Knowledge Courses)
 - ix) Record of observation of peer lessons [at least for **4 (four)** peer lessons]



- x) **Two (2)** Final Lesson Plans (**one in each subject** chosen as Pedagogical Content Knowledge)
- xi) Teaching Learning Materials for Final Lessons
- xii) As the activity related to "holding of examination and evaluation of answer scripts" may not be possible in this Covid 19 pandemic situation, this activity shall be evaluated through *viva-voce*.

Format of Case Study Report for the Course No. BED 40102 (Action Research)

The students of B.Ed. 4th Semester (under Dibrugarh University) shall have to write a detailed **Case Study Report on any** of the following: a working child/a child who has experienced a natural calamity or conflict/an orphan/a street child/urban poor child/out-of-school child/any child from other marginalised and disadvantaged group, etc. (within 2500-3000 words) from their neighbourhood area **in lieu of the Action Research Report** and submit it to the concerned Teacher-in-Charge of their respective institution within the stipulated time.

The report should include the following:

2. Steps to be followed in writing the Report:

- A brief introduction of the category from where the child has been selected for study.
- ii. A brief description of the child along with characteristics.
- iii. Objective of the study.
- iv. Rationale of selecting the child for study.
- v. Tools/Techniques to be used for collection of data.
- vi. Analysis of data [Critical analysis of the challenges (General as well as Educational) faced by the child in the present situation of COVID-19 pandemic and suggestions for improvement].
- vii. Findings.
- viii. Conclusion.

B.Ed. 4th Semester Community Work Programme, 2021

Keeping in view of the current Covid 19 pandemic situation, the B.Ed 4th semester students can undertake at least one of the following activities for the Course: **BED 40201**: Teacher in School and Community in place of the offline organization of Community Camp-

- 1. Online/Telephonic Survey on the issue of Covid 19 or other important social issues can be planned and executed by the B.Ed 4th semester students in their own locality or schools where their online teaching internship programme is going on.
- 2. Online/Telephonic Socio-Economic Survey can be planned and executed by the B.Ed 4th semester students with selected parents of the students of the schools where their online teaching internship programme is going on.
- 3. Need Based Programmes like awareness on Health and Hygiene/Adolescence Education/Adult Literacy/ HIV(AIDS)/Drug Abuse/Conservation and Protection of Environment /Disaster Management can be arrange online by the B.Ed 4th semester students for the Head/Principals/ teachers and students of the schools where their online teaching internship programme is going on.
- 4. Different programmes for example Debate Competition/ Extempore Speech/ Poem Recitation/music /dance can be organized online by the B.Ed 4th semester students for the students of the schools where their teaching internship programme is going on.
