IMPORTANT INFORMATION

- Colleges are requested to submit the big size detail statement of fees in the order so that similar
 kind of fees paid by the candidates should be clubbed together. This is especially required to
 expedite the process of checking the statements manually without any hassle.
- 2. Regarding any update related to the issuance of <u>admit cards</u> and other relevant documents pertaining to the 2nd, 4th and 6th Semester B.A./B.Sc./B.Com. (Non CBCS) Examinations, the colleges are requested to visit the University website (<u>www.dibru.ac.in</u>) or contact the EDPS Section at the mail id <u>sadiq@dibru.ac.in</u> or <u>abhijit@dibru.ac.in</u>
- 3. The colleges that have not deposited the affiliation fees / permission fees, annual affiliation fee of the sports board and fees for section permission etc. to the University are requested to clear the outstanding fees before submission of Examination forms and fees. Please ignore the same if already paid. For details, the concerned colleges may contact the office of the Director, College Development Council.
- 4. The Examination Fees should be deposited by the colleges in the form of Bank Draft drawn in favour of the Registrar, Dibrugarh University payable at Punjab National Bank, Dibrugarh University Branch or through RTGS (A/C No. 0157002100032540, IFSC Code: PUNB0994000, MICR Code: 786024003) and a receipt confirming the payment should be taken from the Finance and Accounts Branch of the University.
- 5. Complying Office Memorandum No. AHE.639/2018/16 Dated, Dispur the 10th June, 2020, the examination fee (Except the Marksheet Fee) for the Academic Session 2020 2021 of all Regular students (domicile from Assam having UID issued by the Govt. of Assam) studying only at various Govt./Provincialised (under Directorate of Higher Education) Colleges and Institutes under the territorial jurisdiction of Dibrugarh University are hereby waived off. However, the benefit of fee waiver will not include non govt. / non provincialised Colleges / Institutes and the self financing courses of the Colleges / Institutes. Colleges are to collect and deposit the Marksheet Fee of the fee waivers at the time of deposition of fees to the University.
- 6. During the course of submission of Examination form at the EDPS section of the Examination Branch, D. U., the Principals of the Colleges are requested to submit a consolidated list of fee waived beneficiaries in excel format (both hard and soft copies). The excel file should contain (i) Sl No., (ii) Registration No., (iii) Name of candidates, (iv) Programme (BA/B.Sc/B.Com), (v) Branch (Major/General/Specialty), (vi) Examination fee waived (in Rs.), (vii) Non-Collegiate fee waived (in Rs.), (viii) Late fine fee waived (in Rs.),

(ix) UID issued by the Govt. of Assam and (x) total amount waived (in Rs.) at the bottom of the sheet.

- 7. The Computer Generated Examination Forms (Excel Format) which shall be issued later on by the EDPS Section, Dibrugarh University must be submitted / returned to the EDPS Section within one (one) week from the date of issuance of the same. The 'App' column in the Excel File shall be filled with 'Y' against the students who filled up and submitted manual examination forms at the College and otherwise, the 'App' column be filled with 'N' for the students who didn't filled up the Examination forms. No Admit Card shall be issued if the Excel File is not submitted to / in the EDPS Section in time.

- 9. All the Principals of the Colleges are requested to inform the examinees well ahead so that no one is left out from the process of filling up the examination form. The University shall not accept examination forms from individual candidates and as such colleges should not forward/request the University in this regard.
