# SECOND ADMISSION NOTICE Five-Year Integrated B.A.LL.B. (Honours) Programme Academic Session 2021-2022

With reference to our earlier Notification NO. **DU/DR-A/Admission- BALLB(H)/ 21/ 1003 Date10.09.2021,** it is informed that three seats are lying vacant belonging to ST(H) as no candidates have taken admission in the said category. Therefore Offline applications are invited from the ST (H) candidates for admission to the **Five-Year Integrated B.A. LL.B. (Honours) Programme** offered by the Centre for Juridical Studies, Dibrugarh University for the session 2021-2022.

### 1. Application Schedule:

- a) Date of issuing Application: 11.10.2021 (From 10.00 a.m. 11 am .) and to be submitted by 12.30 noon on the said day .
- b) The Candidates shall have to collect Application Form from the Centre for Juridical Studies.
- c) The applicants shall be required to pay the Application Fee of Rs. 500/- only through the offline.

#### 2. Selection procedure:

- a. The Selection of eligible candidates shall be **on merit basis** as per the criteria fixed by the University.
- b. The List of Selected Candidates shall be purely provisional and subject to verification of necessary documents. The same will be published on the same day and selected candidates shall have to take admission on the spot by paying fees following the method notified in the notification vide no. **DU/DR-A/Admission-BALLB (H)/21/1116, Dated30.09.2021.**

#### 4. Admission procedure:

- **a.** The selection of the candidates for admission shall be purely provisional and confirmation is subject to verification of original documents by the Committee .
- b. The candidates shall have to bring one set of the documents (photocopy) as per the notification vide No.DU/CJS/06/201/Admission/3061, dated 01/10/2021 to be verified with original documents at the time of admission.
- N. B. If intending candidates do not report for admission before 11a.m. and fill up the forms within the stipulated time on scheduled date, no further claim shall be entertained for admission from the said reserved category and seats shall be allotted to other eligible students.
