
**OFFICE ORDER**

In view of the Order No. ASDMA.28/2021/347, dated 7<sup>th</sup> January, 2022 of the Assam State Disaster Management Authority and regarding surge in cases of Covid-19 as well as increased detection of the variant of concern 'Omicron' the following measures are enforced in the University:-

- (i) The teaching and non-teaching staffs of the University (including contractual and fixed pay) shall attend to their duties on all regular working days in compliance with Covid appropriate behavior viz. frequent washing of hands / sanitization, wearing face mask / cover, observing social distancing at all times.
- (ii) All teaching and non-teaching staffs (including contractual and fixed pay) are to ensure that they are fully vaccinated while attending their respective duties except those in whose case vaccination is contra-indicated as per the guidelines issued by the Health Department, Govt. of Assam and / or such claim is certified by a registered medical practitioner. Such certification should be produced by the employee as and when desired by the competent authority.
- (iii) All the teaching and non-teaching staffs (including contractual and fixed pay) who are not fully vaccinated will not be allowed to attend their duties and they will have to avail leave, if available or extra ordinary leave for which they will not be paid salary.
- (iv) Gathering in closed venues are allowed upto 50% of the seating capacity.
- (v) Persons with Covid-19 symptoms are requested to isolate themselves from others and are requested to immediately inform their respective Controlling Officer. The concerned person should immediately get himself / herself tested and have to submit the test report to the Controlling Officer.
- (vi) Visitors are allowed to stay in the Dibrugarh University Guest House on production of double vaccinated Covid-19 certificate.

This order shall come into force with immediate effect and shall be applicable until further order.


