# Admission Notice for Ph.D. Programmes Session 2021-2022

The intending candidates for admission to the Ph.D. Programmes of Dibrugarh University in the academic session 2021 2022 are hereby informed to apply to the Department/ Centre/ Institute concerned on or before 28.02.2022 as per the provisions below-

## A. The DURAT 2021 Appeared Candidates:

The DURAT 2021 Result held on 08.01.2022 has been declared on 11.02.2022. The University shall publish the Subject-wise lists of Short-Listed Candidates prepared on the basis of the performance of the DURAT, 2021 and these candidates shall be eligible to appear in the Viva-Voce to be conducted by the Department/ Centres for Studies concerned.

The Short-listed candidates (will be notified by 17.02.2022) shall have to submit the following self-attested documents at the Office of the Department/ Centre for Studies concerned from 18.02.2022 to 28.02.2022 during office hours-

- a) A Print-copy of the Online Application Form of the DURAT 2021 submitted to the University.
- b) Copies of the Pass Certificates and Mark Sheets from HSEC to Masters Degree.
- c) Copy of the DURAT 2021 Score card.
- d) Caste Certificate {in case, the Candidate belongs to SC/ ST or OBC/MOBC/ Differently Abled category.}
- e) No Objection Certificate (in case, the Candidate is employed).

### B. The DURAT Exempted Candidates:

(DURAT is exempted for CSIR-NET (both LS and JRF), UGC-NET (both LS and JRF), 'SLET/SET (NE-Region), GATE, GPAT, M.Phil (in regular mode and in the concerned subject), and Teacher Fellowship holder candidates.)

The *DURAT Exempted Candidates* are hereby informed to submit their Applications in the prescribed format (attached herewith as Annexure A) along with the following self-attested documents at the Office of the Department/ Centre for Studies concerned from 18.02.2022 to 28.02.2022 during office hours-

- a) Copy of the Award Letter (in case of UGC-NET (including JRF)/ UGC-CSIR NET (including JRF)/SLET/GATE/GPAT qualified candidates or the Teacher fellowship holder candidates).
- b) M. Phil Pass Certificate and Marksheet (in case of M. Phil passed candidates).
- c) Copies of the Pass Certificates and Mark Sheets from HSLC to Masters Degree.
- d) Caste Certificate {in case, the Candidate belongs to SC/ ST or OBC/MOBC/ Differently Abled category.}
- e) No Objection Certificate (in case, the Candidate is employed).
- f) Receipt of Application Fee payment paid through SBI Collect paid through online payment gateway.

## Eligibility for Admission:

The intending candidates should ensure that their candidature is complied with the eligibility criteria for admission prescribed in Clause 12 of the Dibrugarh University Regulations for the Research Council and for the Degree of Ph.D., 2019 (amended upto date).

# **Reservation Policy:**

Statutory Reservation Policy shall be followed (wherever applicable) as below:

Scheduled Caste (SC) : 7% Scheduled Tribes Plains (STP) : 10% Scheduled Tribes Hills (STH) : 5% of the total seats of the subject OBC/MOBC (non creamy layer) : 15% concerned. Differently Abled : 5%

#### Admission Procedure:

- a) The Teaching Department/ Centre of Studies concerned shall receive the documents/ applications of the intending/eligible candidates till 4.30 P.M. of 28.02.2022.
- b) The list of the candidates invited for Viva-Voce shall be notified by the University concerned in the website: www.dibru.ac.in.
- c) There will be a Viva Voce Examination for all the candidates as below:
  - 1. For 30 % weightage for the candidates qualified the DURAT 2021
  - 2. For 100% weightage for the candidates who are exempted from appearing the **DURAT 2021**

On completion of the Viva-Voce, the Teaching Departments/ Centres for Studies concerned shall prepare the Final Merit Lists for admission, which shall be notified in the University website alongwith the date(s) for admission.

d) The candidates selected for admission shall have to deposit their Admission and Course Fees of Rs. 6,000/- only (Rs.2000/- for the M.Phil Passed candidates) through SBI Collect Online Payment selecting appropriate payment gateway.
