**ADMISSION NOTICE**

**Two Years (4 Semesters) Master of Pharmacy (M. Pharm.) Programme for the academic session 2022-2023**

Online Applications in prescribed form are invited for admission to Master of Pharmacy (M. Pharm.) Programme for the session 2022-2023.

**Two Years (4 semesters) M. Pharm. Programme in Pharmaceutics, Pharmacognosy and Pharmaceutical Chemistry and Pharmacology:**

**Eligibility:** Pass in B. Pharm. Examination with minimum of 55% marks from AICTE & PCI recognized Institute/College/University. The candidate appeared in the B Pharm 8<sup>th</sup> Semester examination and result is expected before the admission to the M. Pharm programme, may also apply. Preference will be given to GPAT qualified candidates. Admission in the Sponsored seats and the seats under EWS category (supernumerary) will be filled up as per approved Rules of the University.

**i) Online Application process will begin from: 27/06/2022**

**ii) Last date for receiving the online filled in application form: 25/07/2022**

**Application Procedure for the Two Years M. Pharm. Programme**

1. Application for **Two Years M. Pharm. Programme** shall be through online mode only. No other means of application shall be accepted.
2. Online Registration for submission of Application Form will begin from **27.06.2022**. The last date for submission of application is **25.07.2022 (till 5.00 p.m.)**
3. For submission of the **Online Application Form**, intending candidates are advised to follow the following instructions:
  - a) The candidate shall be required to visit the Application Portal for admission on the website- [www.dibru.ac.in](http://www.dibru.ac.in).
  - b) The Candidate needs to register on the portal by clicking the "Register" button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
  - c) After successful registration, the candidate needs to login using his/her mobile number and the password.

- d) After login, the candidate needs to click on the "Apply" button corresponding to the link of "Two Years M. Pharm. Programme" which will lead to an application form. *The candidate needs to fill up the application form step by step.*
  - e) After completion of the filling-up the Form Candidate needs to click the button "Submit and Review". A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit
  - f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click 'Pay now & Submit the application" and the pay the application fee of Rs 700/- only through online mode (Debit Card/Credit Card/Internet Banking).
  - g) The application form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.
  - h) There will be a button to download your Application Form for future reference.
  - i) The Submission of Online Application Forms shall be automatically closed after the last date.
4. There shall be no alternative procedure for Application for applying to the **Two Years M. Pharm. Programme** and the University shall not receive the Application except the procedure mentioned at (2) above.

**Additional Information for Admission to M. Pharm. 1<sup>st</sup> semester at Dibrugarh University, Session 2022-23:**

The intake of candidates in different specializations is as follows:

Pharmaceutics : Total intake 08 (04 - General, 02- sponsored, 02 – SC/ST) + EWS 01 (Supernumerary)

Pharmaceutical Chemistry: Total intake 06 + EWS 01 (Supernumerary)


Pharmacognosy: Total intake 06 (05 - General, 01 - SC/ST) + EWS 01 (Supernumerary)

Pharmacology: Total intake 06 + EWS 01 (Supernumerary)

1. Preference will be given to valid GPAT qualified candidates.
2. Candidates seeking admission against seats reserved for S.C/S.T must submit certificates of the cast issued by the Competent Government authorities.
3. Incomplete or late receipt of applications will be rejected.
4. List of selected candidates will be notified in the website.

5. For Non GPAT candidate admission will be on the merit basis considering B. Pharm marks
6. Candidates selected must take admission on the specified date by paying the admission fee and course fee through online payment system only.
7. Candidates selected for hostel seat must take hostel admission on the specified date.
8. Statutory Reservation Policy shall be followed as per the rules of the University.
9. AICTE fellowship will be available for GPAT qualified candidates for all the specializations.


