**NOTIFICATION**

**Subject:** Election of Principals and Teachers of Affiliated Degree Colleges to the different Authorities of the University as per provision of Dibrugarh University Act, 1965 (amended up to date).

It is hereby notified that election to the membership of the Dibrugarh University Authorities against the existing vacancies or caused/ to be caused due to superannuation / expiry of the term of the membership shall be conducted soon, by the following schedule as mentioned under:

**A) D.U. Court: Section 15 (1) A (xiii) :**

One third of the Principals of Degree Colleges affiliated to the University at a time by election from amongst themselves.
