NOTIFICATION


Being the forward step towards implementation of NEP, 2020 and keeping the spirit of Choice Based Credit System (CBCS), the decisions of the Examination Committee of Dibrugarh University adopted vide Resolution No. 5 and Resolution No. 6 in its meeting held on 19.01.2023 are hereby notified for all concerned as under:

Henceforth,

- 1. the Paper Setting of Environment Science / Studies of B. A. / B. Sc. / B. Com. Examinations under CBCS be done by the University and evaluation (non remunerative) be carried out only at the respective Colleges / Centres. Answer keys of this MCQ type Environment Science / Studies paper shall be provided by the University Examination Branch to all concerned immediately after completion of the said examination.**
- 2. The Paper Setting of Multi Disciplinary Ability Enhancement Compulsory Course (AECC) under CBCS B. A. / B. Sc. / B. Com. Examinations be done by the University and Answer keys of this MCQ type AECC shall be provided by the University Examination Branch to all colleges immediately after completion of the said examination. Further, evaluation (non remunerative) of the same shall be carried out only at the College level.**

In this context, for the greater interest of all concerned and required necessary action, the Examination Branch of Dibrugarh University, once again would like to refer the notification vide no. DU/DCE(A)/CoE/SEC/3RD & 4TH Sem./CBCS/Evaluation./2022/775 dtd. 27.10.2022 regarding self evaluation of all 2 credit practical as well as theory based SEC (Skill Enhancement Course) Papers. Henceforth, both the paper setting and evaluation work (non remunerative) of all SEC papers shall be carried out at the college level only.

Entries of all evaluated marks of Environment Science / Studies, AECC as well as SEC Papers of the concerned students at the college level shall finally be incorporated in the existing online mark entry software for CBCS mode by the college itself through the respective course teacher / evaluator(s).
