ADMISSION NOTICE

Four Years (Eight Semesters) Bachelor of Pharmacy (B. Pharm.) Programme for the academic session 2023-2024

Online Applications in prescribed form are invited for admission to Bachelor of Pharmacy (B. Pharm.) Programme for the session 2023-2024.

1. Four Years B. Pharm. (Eight Semesters) Programme: Eligibility:

selected on the basis of merit.

- (A) Seats under State Sponsored Category of Assam: The seats under the category of State Sponsored seats of Assam shall be filled up with the candidates having valid PRC of Assam with the following qualifications:
 - (a) Pass in Higher Secondary (10+2) Examination (Science) of the Assam Higher Secondary Education Council or any other examination recognized by the Dibrugarh University as equivalent to this examination with English, Physics, Chemistry and Biology/Mathematics as the subjects.

OR

- (b) Pass in Two-year Diploma in Pharmacy examination from any institute of Assam recognized by the PCI and AICTE.
- (B) Seats under State Sponsored Category of North-Eastern States other than Assam: The seats under this category shall be filled up with the candidates sponsored by the concerned North-Eastern States other than Assam with eligibility conditions as stated in Para (a) above.
- (C) Seats under Endowment Category: Candidates from any State with eligibility conditions as stated in Para (a) above may apply and will be selected on the basis of merit.
- (D) Admission through lateral entry in B. Pharm. 3rd semester with D. Pharm. qualification under Endowment Category: No. of vacant seats: 05
 Candidates from any State with Two-year Diploma in Pharmacy from any institute recognized by the PCI and AICTE. Selection will be based on merit and performance in the interview.
- (E) Seats under EWS category against Endowment seats (supernumerary): No. of seats: 05

 Candidates eligibility conditions as stated in Para (a) above may apply and will be

1. Candidates seeking admission against seats reserved for S.C/ S.T must submit certificate of caste issued by the Competent Government authorities.

2. Candidates seeking admission against seats under Lateral entry in B. Pharm 3rd semester must submit completion certificate of hospital training issued by the competent authority.

- 3. For the reserved seats 'Wards of Assam Rifles Personnel', the candidates have to send copy of bonafide certificate from competent authority through email to the following email id: office_pharmsc@dibru.ac.in. In case of non availability of the candidates the seats will be opened for General Category students.
- 4. Incomplete or late receipt of applications will not be entertained.
- 5. Sort Listed candidates will be called for counselling at the Department of Pharmaceutical Sciences, Dibrugarh University. No TA/DA is admissible for the purpose.
- 6. The selected applicants shall have to take admission on the date of counselling by paying the necessary admission fee through online mode only (internet banking/debit card/ credit card etc.) as shown below:

(A) State Category : ₹ 6,188/- per year approx.

(B) Endowment Category : ₹ 48,788/- per year approx.

(C) Hestel Admission fee (If allotted) : ₹ 2,900/- per year approx.

(C) Hostel Admission fee (If allotted) : ₹ 2,900/- per year approx.
 7. Candidates selected for hostel seat must take hostel admission on the specified date.

8. Statutory Reservation Policy shall be followed as per the rules of the University.

Application Procedure for the B. Pharm. Programme-

1. Application for B. Pharm. Programme shall be through online mode only. No other means of application shall be accepted.

- 2. Online Registration for submission of Application Form will begin from 22.05.2023. The last date for submission of application is 30.06.2023 (till 11.55 p.m.)
- 3. For submission of the *Online Application Form*, intending candidates are advised to follow the following instructions:
 - a) For Online Application, please login to Admission Portal on https://dibru.ac.in or https://erp.dibru.work/
 - b) The Candidate needs to register on the portal by clicking the "Register" button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
 - c) After successful registration, the candidate needs to login using his/her mobile number and the password.
 - d) After login, the candidate needs to click on the "Apply" button corresponding to the link of "B. Pharm. Programme" which will lead to an application form. The candidate needs to fill up the application form step by step.
 - e) After completion of the filling-up the Form Candidate needs to click the button "Submit and Review". A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit
 - f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click 'Pay now & Submit the application" and the pay the application fee of Rs 750/- only through online mode (Debit Card/Credit Card/Internet Banking).
 - g) The application form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.
 - h) There will be a button to download your Application Form for future reference.
 - *i)* The Submission of Online Application Forms shall be automatically closed after the last date.
- 4. There shall be no alternative procedure for Application for applying to the **B. Pharm. Programme** and the University shall not receive the Application except the procedure mentioned at (2) above.
