### ADMISSION NOTICE

MBA (Full Time), MBA (Part Time) and BBA Programmes for the academic session 2023-2024

Online Applications are invited from eligible intending candidates for admission to the following Programmes for the academic session 2023-2024 offered by the Centre for Management Studies (CMS), Dibrugarh University:

- 1. MBA (Full Time) Two Years (Four Semester) Programme (AICTE Approved)
- 2. MBA (Part Time) three-year Modular Programme
- 3. BBA Three Years (Six Semester) Programme

## Eligibility for:

> MBA (Full Time): A Bachelor Degree in any discipline (except Music and Fine Arts) from a recognized Indian University with at least 50% aggregate marks (45% for SC/ST candidates). Those waiting for their final year results can also apply.

> MBA (Part Time): A Graduate in any discipline with a minimum post qualification working experience of two years at a supervisory level in any organization. Self-employed persons having the above-mentioned qualification and experience may also apply. Candidates except the self-employed shall have to submit a NOC (No Objection Certificate) from his/her employer.

> BBA: Higher Secondary Examination (10+2) in Arts, Science or Commerce of the Assam Higher Secondary Education Council (AHSEC) or an equivalent examination (10+2) recognized as such by the University with at least 50% marks (45% for SC/ST) in aggregate.

#### Admission Procedure:

- MBA (Full Time): The admission procedure consists of:
  - Written Test (45% weightage): Candidates have to take the MAT (Management Aptitude Test) examination conducted by All India Management Association / CAT (Common Admission Test) conducted by IIMs or CMAT (Common Management Admission Test) conducted by AICTE. Sponsored and / or foreign candidates are exempted from appearing in the Written Test.
  - Group Discussion (30% weightage) and Personal Interview (25% weightage): Candidates who have a valid MAT / CAT / CMAT Score (as fixed by the Centre after the application process) or otherwise qualified as mentioned above will be called for a GD and PI.

The final selection will be based on the candidate's overall performance.

- MBA (Part Time): Candidates are selected on the basis of their performance in a written examination, personal interview and industry experience.
- BBA: Candidates will be selected based on the marks obtained in their 10 + 2 exams (80% weightage) and the marks obtained in a Personal Interview that the candidates have to appear (20% weightage).

Last date for receiving the online filled in Application Form: 20/06/2023 [for MBA (FT) and BBA]

13/08/2023 [for MBA (PT)]

The candidates will have to pay Rs.700/- only as Application fee through the online portal.
