**Admission Notice
NCTE Recognized Two Year B.Ed. Programme
Academic Session 2024-2025**

Online Applications are invited from eligible candidates for admission to the NCTE recognized Two Year B.Ed. Programme conducted by the Department of Education, Dibrugarh University during the session 2024-2025

A. Application Procedure:

1. Application for Two Year **B.Ed. Programme** shall be through online mode only. No other means of application shall be accepted.
2. Online Registration for submission of Application Form will begin from **20.07.2024**. The last date for submission of application is **28.07.2024 (till 11.59 p.m.)**
3. For submission of the **Online Application Form**, intending candidates are advised to follow the following instructions:
 - a) For Online Application, please login to Admission Portal on <https://dibru.ac.in> or <https://erp.dibru.work/>
 - b) The Candidate needs to register on the portal by clicking the “Register” button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
 - c) After successful registration, the candidate needs to login using his/her mobile number and the password.
 - d) After login, the candidate needs to click on the “Apply” button corresponding to the link of “**B.Ed. Programme**” which will lead to an application form. *The candidate needs to fill up the application form step by step.*
 - e) After completion of the filling-up of the Application Form, Candidate needs to click the button “Submit and Review”. A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit
 - f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click ‘**Pay now & Submit the application**’ and then pay the

application fee of Rs 950/- only through online mode (Debit Card/Credit Card/Internet Banking).

g) The Application Form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.

h) There will be a button to download your Application Form for future reference.

i) The Submission of Online Application Forms shall be automatically closed after the last date.

4. There shall be no alternative procedure of application for applying to the **2-Year B.Ed. Programme** and the University shall not receive any Application except the forms submitted as the procedure mentioned at (2) above.

5. Candidates seeking admission under the Non-Statutory Reservation Quota in the category of **Sons and Daughters of the DU Employees/Retired Employees** shall have to submit a print out of the Submitted Online Application Form of the **B.Ed. Programme 2024** along with the self-attested copies of all relevant testimonials and a Filled in Prescribed Form on or before **29.07.2024** at the Department of Education, Dibrugarh University [*Please refer Clause No. 2 (IV) (b) of 'Reservation and Relaxation Policy for admission into Post Graduate, Under Graduate, Advanced Post Graduate Diploma, Post Graduate Diploma, Diploma and Certificate Programmes (Revised upto February 2022)* available in the Dibrugarh University Website].

Note : Certificate from competent authority must be submitted. Attach additional sheet if necessary

Important Note:

After submission of the online Application Form, the Candidates shall have to take a print out of the submitted Application Form and submit the same at the Office of the Department of Education, Dibrugarh University **on or before 29.07.2024** along with the following documents:

** Statutory Reservation Policy shall be followed as per the Government Rules by the University while preparing the Merit List of the candidates.*

B. Eligibility:

Candidates with at least 50% marks (in Aggregate) *either in the Bachelor's Degree and /or in the Master's Degree in Sciences / Social Sciences / Humanities / Commerce OR Bachelor of Engineering / Bachelor of Technology of Dibrugarh University or from any other recognized University with Science and Mathematics securing at least 55% marks or any other qualification equivalent thereto are eligible for admission.

*As per the NCTE norms, a candidate securing 50% marks or more in the Honours/ Major subject but less than 50% in aggregate in all the courses/ papers of the Bachelor's degree will not be eligible for admission to the B.Ed. Programme as the requirement is minimum 50% marks in the aggregate.

Qualified the B.Ed. CET, 2024 with valid score conducted by Dibrugarh University on 13.07.2024.

C. Relaxation:

Relaxation of marks upto 5% in the qualifying examinations may be granted to the following candidates:

- (a) Candidates belonging to the SC/ ST/ OBC/MOBC/ PWD categories,
- (b) Teacher candidates with minimum of five years teaching experience in a school recognized at least upto 10th standard by the Board of Secondary Education, Assam.
- (c) A candidate can avail the benefit of relaxation of marks only in any one of the above categories.
