4. Caste Certificate, issued by competent authority.
5. Latest E W S Certificate for the candidates belonging to the category from the Competent Authority, where necessary.
6. Gap Certificate, if applicable
7. Permanent Residence Certificate (PRC) from the Competent Authority
8. Personal email id of the candidates with contact no having whatsapp .

**Timing of Admission** - From 10.30 a.m. onwards and shall be closed by 4.00 pm and students shall have to respond immediately for admission after calling their name(S) in order. If not responded to the call, the seat shall stand forfeited and next student shall be admitted. Therefore they are advised to be present at the Centre for Juridical Studies, Dibrugarh University by 10.30 AM positively and sign the attendance register by 10.30 AM. The candidates are advised to visit regularly university website for any information.

**The candidates included in the waiting list (category wise) shall appear before the Admission Committee on 19<sup>th</sup> July, 2024 at 10.30 A.M. for admission against the vacant seats.**
