EXEMPTED FROM APPEARING DIBRUGARH UNIVERSITY RESEARCH
ADMISSION TEST (DURAT)**

SESSION 2024-25

Applications are invited from the intending candidates who have qualified the CSIR/UGC NET-JRF and/or having research fellowship from National level Government/Semi Government funding agencies and/or have passed M.Phil. programme (in regular mode and in the concerned subject) for admission to the Ph.D. programme, 2024-2025 session in the following subjects:

Eligibility Criteria:

- (i) A candidate seeking admission to the course for the Degree of Doctor of Philosophy (Ph.D.) shall have to complete a 1-year/2-semester Master's degree programme after a 4-year/8-semester Bachelor's degree programme or a 2-year/4-semester Master's degree programme after a 3- year Bachelor's degree programme or qualifications declared equivalent to the Master's degree by the corresponding statutory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed.

Provided that a candidate seeking admission after a 4-year/8-semester Bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC, Differently-Abled, Economically Weaker Section (EWS).

Not more than 50% of the seats in the subject concerned shall be filled up by the candidates, who are exempted from appearing the DURAT as per the provisions above.

- (ii) A candidate may also be enrolled if she/he has any other degree recognized as equivalent to the Master's Degree in the subject in which the candidate wishes to pursue a course of research, provided the candidate fulfills the conditions at (i) above.
- (iii) Under special circumstances, a candidate may be allowed by the Research Council to undertake research in a subject other than one in which she/he has obtained Master's Degree. Before permitting the candidate to do so, the Council shall satisfy itself that the branches are inter-related and/or the candidate is competent to undertake research in the particular subject as evidenced by published/practical works.
- (iv) A candidate with a B.E./B.Tech. Degree with a valid JRF-GATE score may also be considered for admission to the Ph.D. programme.
- (v) The intending candidates should ensure that their candidature is complied with the eligibility criteria for admission prescribed in Clause 12 (A) and 12 (B) of the Dibrugarh University Regulations for the Research Council and for the Degree of Ph.D., 2023.

For submission of the *Online Applications*, the intending candidates are advised to follow the following procedure:

- a. The candidate shall be required to register in the Online application Portal given in the website- www.dibru.ac.in by entering Full Name, Password and a Mobile Number. The candidate will get an OTP in the Mobile Number which is to be entered for Activation.
- b. After Activation, the candidates shall be required to login by entering his/ her Mobile Number and password.

- c. The applicants shall be required to pay the **Application Fee of Rs. 950/- only through the online payment gateway** by using Debit (ATM) Card/Credit Card/ Internet Banking during the submission of the Application Form. **No other mode of payment is acceptable.**
- d. The applicants can save and review the information entered before **submission**, which can be edited on subsequent login. However, after submission, editing of information shall not be possible.
- e. On successful submission of the **Online Application Form with Payment of Application Fee**, the Candidates will get a Fee Payment Receipt. **The Candidates should take a print out of the Payment Receipt and Application Form.**

The applicants need to submit the Print-Copy of the application form along with the following self-attested documents **at the Office of the Department/ Centre of Studies concerned where they wish to apply for the Ph.D. Programme -**

- (i) Copy of the Award Letter (in case of CSIR/UGC NET-JRF qualified candidates and/or candidates having research fellowship from National level Government/Semi Government funding agencies).
- (ii) M.Phil. Pass Certificate and Marksheet (in case of M.Phil. qualified candidates).
- (iii) Copies of the Pass Certificate and Mark Sheets from HSLC to Master's Degree.
- (iv) Caste Certificate [in case the Candidate belongs to SC/ ST and OBC/MOBC (**Non-Creamy layer**)] or Certificates related to PWD and EWS.
- (v) No Objection Certificate (in case the Candidate is employed).

Last date of receipt of hard copies of the documents at the concerned Departments/Centres of Studies: 20/08/2024 (till 5:00 pm)

Reservation Policy:

Statutory Reservation Policy shall be followed (wherever applicable) in admission to the Ph.D. Programme.

Admission Procedure:

- a) The list of the candidates short listed for Viva-Voce shall be notified by the concerned Department/Centre of Studies in the University website: www.dibru.ac.in.

- b) There shall be a Viva Voce Examination for all the candidates as per the following details:
1. For 100% weightage for the candidates who are exempted from appearing the DURAT.

On completion of the Viva-Voce, the Teaching Departments/ Centres of Studies concerned shall prepare the Final Merit Lists for admission, which shall be notified in the University website along-with the date(s) for admission.

- c) The candidates selected for admission shall have to deposit their Admission and Course Fees of **Rs. 6,000/-** only (**Rs. 2000/- for the M.Phil. Passed Candidates**) through *online mode at the time of admission*.
- d) All the Departments/Centres of Studies shall complete the admission process by **06/09/2024**.
