- 2. The candidates provisionally selected for admission must appear in the counseling to be held on 5<sup>th</sup> August, 2024 from 10:00 A.M. in the office of the Head, Department of Economics, Dibrugarh University. Candidates must report at 9:45 a.m. positively.
- 3. The candidates provisionally selected for Admission (under any category) shall have to bring the following documents on the date of admission:
  - a. A print copy of the Online Application submitted along with the photocopies of all relevant testimonials.
  - b. DUPGET 2024 Score Card.
  - c. Graduation Markesheet/Gradesheet and Pass Certificate.
  - d. Class 10<sup>th</sup> and12<sup>th</sup> Marksheet and Pass Certificate.
  - e. Caste Certificate [viz, SC, SI (P), ST (H), OBC/MOBC (Non Creamy Layer Certificate), EWS Certificate etc. (whichever is applicable).
  - f. Income Certificate [as per the Office Memorandum of the Higher EducationDept.,Govt.ofAssamvideMemoNo.490503/2024/10,dated 14/06/2024], Domicile certificate/ Permanent Residence Certificate (PRC) of Assam for claiming fee waiving benefit.
  - g. Undertaking on Provisional Admission (Format of Undertaking shall be available in the University website)
  - h. Gap Certificate in the form of Affidavit, if relevant.
  - i. All documents in original for producing before the Admission Committee.
  - j. The Admission Fee, Course Fee. etc. (Wherever applicable as per the Fee Structure given in the website).
- 4. The Admission and course Fees shall be as per the approved Fee Structure of the University. The Admission Fee, Course Fee, etc. (wherever applicable) to be paid by the candidates at the time of admission through online mode only.
- 5. The Selection and Admission shall be purely provisional and subject to fulfillment of requisite norms of Qualifying examinations and other relevant criteria.
- 6. In case of equal Score in DUPGET 2024, the candidates securing higher percentage of marks at 10+2 level are placed higher.
- 7. The Statutory Reservation Policy of the Government of Assam has been followed in preparation of Merit lists. Besides it, the University also follows its own Reservation and Relaxation Rules as approved by the Academic Council.

- 8. Admission from the waiting list against the vacant seats, if any, shall take place on the same day i.e. 5<sup>th</sup> August, 2024 from 10:30 a.m. Candidates must report at 10:00 p.m. positively.
- 9. Anti-Ragging Declaration: Admitted students are directed to submit the ANTI-RAGGING undertakings as instructed in the website on the day of the Admission.
- 10. The candidates who have applied for the OBC/MOBC (Non creamy layer) certificate may be allowed to take admission, subject to submission of acknowledgement receipt generated from the Govt. of Assam website. However, the candidates have to submit the Non-Creamy Layer certificate with 15 days from the date of his/her admission, otherwise, his/her admission stands automatically cancelled.
